

### Synopsis of Electronic Tenant Registration Policy & Board Resolution

May 28, 2025

RE: Notice of Board Approval - Electronic Tenant Registration Policy & Board Resolution on Director Term Adjustment for Iron Horse Village Residential Homeowners Association, Inc., Mesquite, Texas

Dear Homeowners,

At a duly called meeting of the Board of Directors held on May 15, 2025, the Board voted to formally adopt the following measures:

- 1. Electronic Tenant Registration Policy
- 2. Board Resolution Adjusting Terms of Directors

Please see below a brief synopsis of each item. Full copies of both documents are attached to this notice and the Electronic Tenant Registration Policy has been officially filed with the Dallas County Clerk's Office. The policy and resolution are now considered in full effect as of the date of delivery of this letter.

#### **Electronic Tenant Registration Policy Summary**

#### Purpose:

The policy was enacted to simplify communication and facilitate controlled pool access for tenants renting within the Iron Horse Village community.

#### **Key Requirements:**

- Tenant Registration: Owners must complete an online tenant registration form through the Association's website to obtain pool key cards for their tenants.
- Required Tenant Information:
  - o Names
  - Phone numbers
  - o Email addresses
  - Lease start and expiration dates
- Owner Acknowledgements (via online form):
  - o Tenant(s) have received the Association's governing documents
  - o Tenant(s) agrees to receive email communication from the Association
  - o Pool key cards will be deactivated on the lease's expiration date
  - Owners may request new key cards upon lease renewal or new tenant registration

#### Compliance Deadline:

Owners have 60 days from the date the policy is filed with the Dallas County Clerk to comply. **Enforcement:** 

Violations of the policy may result in fines as per the Association's enforcement procedures.

#### **Modification Clause:**

The Board reserves the right to amend this policy or introduce additional rules.

# IRON HORSE VILLAGE RESIDENTIAL HOMEOWNERS ASSOCIATION, INC. ELECTRONIC TENANT REGISTRATION POLICY

In order to respond to the need for ease in communication and key card for pool access for Tenants residing in the community and for ease of use of Owner's renting their residences within the community, the Board of Directors have promulgated this Electronic Tenant Registration Policy.

- In order for an Owner to receive pool key cards for their Tenant(s) and to be in compliance
  with the Association's governing documents, an Owner must submit the following
  information via an online registration form provided on the Association's website:
  - o Name of Tenant(s)
  - Phone Number of Tenant(s)
  - o E-mail address(es) for Tenant(s)
  - o Start Date and Expiration Date of Lease Term
- Within the online registration form, Owner must acknowledge:
  - o The Tenant(s) have received the Association's governing documents,
  - The Tenant(s) shall receive e-mail communications from the Association until the stated Expiration Date of the Lease Term,
  - Key cards for pool access for the Tenant(s) shall be turned off at the Expiration Date of the Lease Term, and
  - o The Owner is authorized to request new key cards for pool access when either (1) the current Tenant(s) renews his or her lease or (2) the new Tenant(s) are registered using the online registration form provided on the Association's website.
- Owners shall have sixty (60) days from the date of filing this Policy with the Dallas County Clerk to comply with this Policy.
- Violations of this Policy may subject an Owner to fines pursuant to the Association's Enforcement Policy.
- The foregoing Policy is subject to amendment by the Board of Directors and to the promulgation of further Policies and/or Rules.

# RESOLUTION OF THE BOARD OF DIRECTORS OF IRON HORSE VILLAGE RESIDENTIAL HOMEOWNERS ASSOCIATION, INC.

WHEREAS, the Board of Directors of Iron Horse Village Residential Homeowners Association, Inc. (the "Board") is the entity responsible for the operation of Iron Horse Village Residential Homeowners Association, Inc., a Texas nonprofit corporation (the "Association") in accordance with and pursuant to the Declaration of Covenants, Conditions and Restrictions for Iron Horse Village was filed on September 23, 2019, as Instrument No. 2019-00253417 in the Official Public Records of Dallas County, Texas (the "Declaration") and the Bylaws of Iron Horse Village Residential Homeowners Association, Inc. (the "Bylaws"); and

WHEREAS, under Article IV, Section 4.1(b) of the Bylaws, after the Declarant Turnover Date, as defined in the Bylaws, the Members will elect a minimum of three (3) Board of Directors; one (1) Director for a three (3) year term, and two (2) Directors for a two (2) year term; and

WHEREAS, under Article IV, Section 4.1(b) of the Bylaws, the Member obtaining the most votes will serve the three (3) year term and the remaining two (2) Directors will serve a term of two (2) years; and

WHEREAS, at the 2024 election following the Declarant Turnover Date, three (3) Directors were elected by the Members; and

WHEREAS, Member Shaquerra Hamilton obtained the most votes and, as such, was to serve a term of three (3) years; and

WHEREAS, Director Shaquerra Hamilton voluntarily resigned from the Board resulting in an immediate vacancy; and

WHEREAS, the Board has determined the need to maintain stability on the Board amongst the remaining Directors until such time the vacancy is filled pursuant to the Bylaws; and

WHEREAS, a meeting of the Board was held on the day of \_\_\_\_\_, 20\_\_\_; and WHEREAS, a quorum of the Directors was present at the meeting; and

WHEREAS, a Motion was made Director Perla Bouche fulfill the remaining three (3) year term of former Director Shaquerra Hamilton and shall hold office until her successor has been elected; and

WHEREAS, the Motion was discussed and presented for a vote at the meeting; and
WHEREAS, the Board determined that it was in the best interests of the Association to
adopt the Motion; and

WHEREAS, the Directors present at the meeting voted unanimously to resolve adopt the Motion on the above date.

NOW, THEREFORE, BE IT RESOLVED that the term of Director Perla Bouche be set from two (2) years to three (3) years.

IT IS FURTHER RESOLVED, that this Resolution shall forthwith be recorded in the Official Public Records of Dallas County, Texas, until otherwise modified or rescinded by the Board. All Owners shall receive notice of this Resolution.
